

O-Week Evaluation Survey 2017 (Curtin Bentley Campus) Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this Competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 (“Curtin”).
5. The O-Week Evaluation Survey 2017 (Curtin Bentley Campus) commences at 9am Australian Western Standard Time (AWST) on Wednesday 1 March 2017.
6. The closing time for entering the competition is 5pm Australian Western Standard Time (AWST) on Sunday 26 March 2017.
7. To enter the Competition, entrants must:
 - a) Receive an invitation from Curtin University to complete an online questionnaire;
 - b) Be a Curtin student, enrolled at or via the Curtin Bentley campus during the survey period (includes external study mode students); and
 - c) Complete the online questionnaire in full by the closing time and date.
8. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
9. Entrants may only enter the Competition once.
10. There will be one (1) draw at 11am Australian Western Standard Time on Tuesday 2 May 2017, at the Student Transition and Retention Team Office, Building 103, Level 1, Curtin University, Kent Street, Bentley. The draw will be by a random number generation using the Random Integer Generator provided by RANDOM.ORG with each entry assigned a unique and sequential identifying number. Using only the RANDOM.ORG Random Integer Generator, five (5) identifying numbers will be returned as winners.
11. There will be five (5) prizes. Each prize will be \$100 of Coles or Myer vouchers.
12. Each prize winner will be contacted within seven (7) days of the draw by phone or email using the information provided by the entrant in the questionnaire.
13. If the prize winner does not respond to claim the prize within 21 days of the draw, a re-draw will be conducted within 30 days of the original draw date, in the same location and with the same method. Redraws will continue in the same manner until all prizes have been claimed by prize winners. The winner will be contacted as per clause 12.
14. If the prize winner is under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
15. The prize may be collected in person by the prize winner or parent/legal guardian or may be mailed / couriered.
