

## 2024 Insight May survey event Competition Terms and Conditions

- 1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
- 2. By entering the competition, entrants agree to abide by these Terms and Conditions.
- 3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
- 4. The competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 ("Curtin University").
- 5. The 2024 **Insight May** survey event Competition ("the competition") will commence at 9:00am Australian Western Standard Time (AWST) on **8 May 2024.**
- 6. The competition will close at 11:59pm AWST on 1 July 2024.
- 7. The competition is open to students from participating campuses, and who are enrolled in units running in the study periods included in the **Insight May** survey event (which runs between **8 May 2024** and **1 July 2024**).
- 8. To enter the competition, students must complete and submit a unit evaluation between 8 May 2024 and 1 July 2024.
- 9. Entrants will automatically enter the competition with each successful submission of a unit evaluation.
- 10. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
- 11. Staff employed by Curtin University and their immediate family members are not eligible to enter the competition.
- 12. By entering the competition, the students agree that they are over the age of 18 years, or if under the age of 18 years, have their parent's or legal guardian's consent to enter the competition.
- 13. The prize winner, or if under the age of 18 years their parent or legal guardian, may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving the prize.
- 14. The prizes comprise of:
  - fifteen (15) x AUD50 Prezzee gift card\*
    The total prize pool is valued at AUD\$750

- 15. There will be one (1) draw at 2:30pm Australian Western Standard Time on 25th July 2024 at Building 100, Level 4, Curtin Strategy and Marketing, Curtin University, Kent Street, Bentley. The draws will be by a random number generation using the Random Integer Generator provided by RANDOM.ORG with each entry assigned a unique and sequential identifying number. Using only the RANDOM.ORG Random Integer Generator, identifying numbers will be returned as winners.
- 16. The prize winners will be contacted within seven (7) days of the draw by the email addresses or telephone contacts available in the Student One student database system.
- 17. If the prize winner does not respond to claim the prize within twenty-one (21) days of the draw, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method.
- 18. The prize winners' names will be published on the Curtin website and possibly in emails and/or OASIS OCC messages. By entering the competition, students grant Curtin permission to use their full name and course of study in public announcements.
- 19. Curtin's decision will be final and no correspondence will be entered into.
- 20. Curtin is not responsible in any manner whatsoever for any problems or any financial costs incurred, or any combination thereof, including any injury or damage to participants or any other persons related to or resulting from participation in this competition.
